Under the Customs Laws of Belize, all persons leaving Belize are required to declare any currency in their possession in excess of \$20,000.00 BZD or foreign currency equivalent. If you are carrying currency in excess of \$20,000.00 BZD or foreign currency equivalence, you must complete a "Report of Currency Importation" Form C300, to be supplied by a Customs Officer. Only one Report of Currency Form per family is required and shall be completed by the head of the family.
